### About the Society of London Theatre

The Society of London Theatre (SOLT) is the Membership Organisation for London Theatre Producers, Managers, Owners and Operators.

We work in partnership with our sister organisation, [UK Theatre](#).

**Our Vision**, and the world we want to see, is a dynamic, sustainable and world class theatre sector.

**Our Mission**, and what we do as an organisation, is to champion theatre and support our members to thrive.

We deliver a range of services both to assist our members and to promote theatregoing to the widest possible audience. This includes but is not limited to legal and employment relations advice, marketing support, workforce development, health and safety and lobbying.

### Associate Membership

Thank you for your interest in becoming an Associate Member of SOLT. Started in 2023, this category of membership is designed to identify and support producers and future theatre/performing arts industry leaders who would not currently be eligible for membership under our existing articles of association (our rules of membership).

We are actively encouraging applications from groups who have historically been underrepresented within SOLT's membership over the last 116 years, to ensure the membership is more inclusive and represents a broader group of future industry leaders.

This membership provides a range of member benefits and experience to encourage career progression and access to best working practices.

After two years of SOLT Associate Membership, the membership team will support those members who are ready and eligible to apply for either SOLT Deposit or Organisation Memberships. The membership team will also support applications to UK Theatre, our sister organisation which represents theatre professionals beyond London and the West End.

### Membership Benefits

Associate membership is free of charge and gives access to SOLT Membership benefits, including:

- Access to members' meetings, webinars and networking events
- Access to SOLT newsletter including regular industry updates
- Access to membership rates for all training and conferences
- Olivier voting rights (including tickets to eligible productions)
- Access to the Legal and ER teams for eligible shows as per the current membership rules (production must take place in a SOLT member venue)
- Marketing support via the SOLT channels, including TKTS and Ticketing Promotions (there will be limitations re production taking place in a SOLT venue to access all channels)
- Voting rights – Members who are Associate Members shall have the same voting rights as Full, Deposit and Organisational Members, except they shall not be entitled to vote in respect of resolutions relating to employment relations matters and financial issues
- Access to the membership team to check-in on progress and ensure new members are supported

In addition to these benefits, SOLT Associate have unique access to

- A mentor from the wider SOLT membership
- Discounted tickets to Olivier Awards ceremony
- Peer network and quarterly in-person meetings tailored to SOLT Associates
- Access to the SOLT Board and President to discuss career development

When they become eligible to join SOLT during or after their two years of free membership, Associate members will receive a 70% discount on their first year of Deposit membership.

### **Career development**

We believe that by engaging with the above member benefits will in-turn provide the following:

- A better understanding of best practice across a spectrum of industry issues
- Access to an industry network, mentoring and support
- An ability to grow as a producer and/or industry leader at a fast-tracked pace
- Access to see SOLT member productions

### **Inclusion**

We are encouraging people from different backgrounds with different experiences, skills and stories to join us and influence and develop our working practice. Therefore, we are particularly keen to hear from black, Asian and ethnically diverse applicants. We are also particularly keen to hear from disabled candidates (who will be guaranteed an interview), and candidates who self-identify as from a low socioeconomic background.

To help us achieve these aims we will be asking applicants to supply additional information about themselves during the application process and some of these include information about protected characteristics. You do not have to supply us with any of this information if you do not wish to.

### **Obligations**

As an Associate Member, you will be a representative of Society of London Theatre and expected to act responsibly in your working practices. You will be asked to fulfil several obligations and you should consider these carefully before applying.

Associate Members must:

- adhere to the collective agreements and minimum rates of pay on any production as set out in the [Terms and Conditions of Membership](#).
- place Deposits with The Theatre Council for any production in a SOLT venue, unless exempt under the Terms and Conditions of Membership.
- must comply with SOLT's [Articles of Association](#) and [Terms and Conditions of Membership](#).

### **Timeline**

- **Applications open:** Wednesday 10 December 2025
- **Applications close:** Friday 6 February 2026
- **Interviews:** w/c 16 February 2026
- The interview panel (chaired by the President) will make a recommendation to the Board about who to offer the Associate Memberships.
- **Ballot to members:** All membership is subject to a ballot of the SOLT membership. If no objections are received, we can proceed.
- **Start of membership:** May 2026 for a period of 2 consecutive years.

## FAQs

### How do I apply?

To apply, please complete the online application form by **6 February 2026**. The application will ask for a copy of your current CV and details of an industry referee. You can view a PDF of the application [here](#).

### When will I know the outcome of my application?

We will contact every applicant to let them know whether they are being invited to interview.

### Who is eligible?

The Associate Membership category is available for producers and/or those working in SOLT membership venues/organisations who can demonstrate their potential in becoming industry leaders of the future.

Producer applicants are likely to have had some experience of producing / co-producing in the West End. This may have been on 'one-nighter' productions. They may already be engaged with Stage One and their development programmes, including Bridge the Gap.

Applicants such as general managers will be able to demonstrate that they have the potential to be future industry leaders and CEOs.

### Who can be my industry referee?

All applicants will be required to provide an industry referee whom they have worked with over the past 18 months. This can be a colleague, artist, employer or collaborator. Your industry referee does not need to be a SOLT member or known by the organisation. Please ensure they have given permission for us to contact them about your application.

### How will interviews be conducted?

Interviews will be conducted by a panel of SOLT members, including representatives from the Board. Our preference would be for interviews to take place in person at the SOLT offices at 32 Rose Street, WC2E 9ET. However, we can organise an online interview. If travelling to London and attending an interview presents a financial barrier, please contact us and we will help to subsidise the cost either in part or entirely.

### If my application is successful, what will happen at the end of my 2-year Associate Membership?

After two years your Associate Membership will lapse, but the membership team will continue to support Associate 'alumni' to stay connected with SOLT & UK Theatre.

If you meet SOLT's eligibility criteria you will be to apply to become a Deposit or Organisation Member (in accordance with the rules at that time).

The membership team will also be happy to support and advise on applications to UK Theatre.

### Will I be able to be co-opted or elected to the Board as an Associate Member?

No, Associate Members will not be eligible to join the Board.
